- ii. so as to give you the opportunity to study/being trained/teach at NKUA and develop your critical thinking (or skill in general). In this way, NKUA will fulfil its mission as a Higher Educational Institution, performing a task carried out in the public interest [Article 6.1(e) of EU GDPR].

The submitted personal data will be kept on our record files (electronically or in hardcopy) for 5 years for the well performance of the contract or in a possible control

by the State Scholarships Foundation (IKY), controllers of the European Commission, Ministry of Education, Religious Affairs and Sports, the Hellenic Court of Audit, and the European Anti-Fraud Office.

If, for any reason, you do not submit your final online application to the Programme, we will keep your personal data until the end of the Erasmus Programme in which you initially expressed interest.

You have the right of access, rectification of your personal data, or erasure, where technically feasible, the right to restriction of processing, or, where applicable, the right to data portability, or the right to object to processing of personal data, in accordance with the Regulations (EU) 2016/679 and 2018/1725, and the Law No 4624/2019 of the Hellenic Republic.
